Changes to Regulations

The General Purposes Committee of Council has made the following changes to regulations, to come into effect on **13 November**.

(a) Establishment of the Chingiz Gutseriev Archaeology and Anthropology Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the gift from Said Gutseriev, to endow the salary, expenses and associated overheads of an existing research post in Archaeology and Anthropology.

Text of Regulations

In Council Regulations 24 of 2002, insert:

'Chingiz Gutseriev Archaeology and Anthropology Fund

1. The University receives with gratitude the sum of £2,604,200 from Said Gutseriev to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Chingiz Gutseriev Archaeology and Anthropology Fund ("the Fund").
2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the salary, expenses and associated overheads of: (i) the holder of the current Chingiz Gutseriev Research Fellowship in Archaeology and Anthropology; and subsequently (ii) the holder of the Chingiz Gutseriev Associate Professorship in

Archaeology and Anthropology (each, "the Post"). The Post holder shall undertake research, lecture and teach in and at the interface of Archaeology and Anthropology. Part of the Fund shall be hypothecated to support the costs of St Peter's College, Oxford, in establishing and maintaining a College fellowship for the holder of the Post ("the Fellowship").

4. If the salary, expenses and overheads of the Post and Fellowship are wholly or partly covered from other sources or there are further funds available, there shall be discretion to apply the income and/or capital of the Fund to support the Post holder's research activities (including, but not limited to, fieldwork, research travel, conference attendance and organisation, and outreach).

5. The administration of the Fund, and the application of its income, shall be the responsibility of the Social Sciences Divisional Board.

6. Provided the Post and the Fellowship can be maintained from year to year, the University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

7. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the Post, provided always that such costs shall not exceed those charged by the University from time to time in relation to other funds or posts similar in nature to the Fund or the Post.

8. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

9. Regulations 1-11 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

10. Subject to Regulation 11, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

- (1) cease to be exclusively charitable according to the law of England and Wales; or
- (2) be outside the objects of the University.

11. Any amendment to Regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.

(b) Establishment of the Harle Bodleian Fund for Indian Studies

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the legacy gift from Betty Harle, for the purpose of acquiring and maintaining books and periodicals dealing with the Indian sub-continent, particularly those dealing with art and archaeology.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'Harle Bodleian Fund for Indian Studies

1. The University receives with gratitude the sum of £231,146 from Betty Harle to be held as an expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Harle Bodleian Fund for Indian Studies ("the Fund").
2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, for the purpose of acquiring and maintaining books and periodicals dealing with the Indian sub-continent, particularly those dealing with art and archaeology.

4. The administration of the Fund, and the application of its income, shall be the responsibility of Bodley's Librarian, subject to oversight by Curators of the University Libraries.

5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund.

7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

8. Regulations 1-10 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

9. Subject to Regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

- (1) cease to be exclusively charitable according to the law of England and Wales; or
- (2) be outside the objects of the University.

10. Any amendment to Regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

(c) Establishment of the Instruction in Mandarin Chinese Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the legacy gift from Mary Lackey, for the purpose of maintaining an instructorship in Mandarin Chinese.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'Instruction in Mandarin Chinese Fund

1. The University receives with gratitude the sum of £850,000 from Mary Lackey to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Instruction in Mandarin Chinese Fund ("the Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, to maintain an instructorship in Mandarin Chinese ("the Post"). The Post holder shall tutor and teach Mandarin Chinese, including, but not limited to, the provision of training students in both conversational and interpreting skills.

4. Any surplus income available after the provision of the Post shall be used for the benefit of Chinese Studies within the University or be placed on reserve for expenditure in the subsequent year as if it were income of that subsequent year.

However, the Fund shall not be used to support the building or maintenance costs of any language laboratories, nor the purchase of any computing equipment associated with such laboratories.

5. The administration of the Fund, and the application of its income, shall be the responsibility of the Humanities Divisional Board.

6. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

7. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund and the Scholarship.

8. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

9. Regulations 1-11 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

10. Subject to Regulation 11, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

- (1) cease to be exclusively charitable according to the law of England and Wales; or
- (2) be outside the objects of the University.

11. Any amendment to Regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

(d) Establishment of the June and Simon Li Graduate Scholarship in the History of Chinese Art Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the gift from the T. June and Simon K.C. Li Charitable Fund for the purpose of providing named DPhil Scholarships in the History of Chinese Art, within the History of Art Department.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'June and Simon Li Graduate Scholarship in the History of Chinese Art

1. The University receives with gratitude the sum of £1,550,491 from the T. June and Simon K.C. Li Charitable Fund to be held as an expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the June and Simon Li Graduate Scholarship in the History of Chinese Art Fund ("the Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, to provide named DPhil Scholarships in the History of Chinese Art, within the History of Art Department.

4. The administration of the Fund, and the application of its income, shall be the responsibility of the Humanities Divisional Board.

5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such

income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund and the Scholarship.

7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

8. Regulations 1–10 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

9. Subject to Regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

- (1) cease to be exclusively charitable according to the law of England and Wales; or
- (2) be outside the objects of the University.

10. Any amendment to Regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.

(e) Establishment of the Madame L.C. Yuen Chen Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the gift from Henry Chan for the purpose of acquiring and maintaining Chinese books, journals and databases in the Bodleian Libraries.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'Madame L.C. Yuen Chen Fund

1. The University receives with gratitude the sum of £1,000,000, from Henry Chan to be held as a permanent endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Madame L.C. Yuen Chen Fund ("the Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment; and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, for the purpose of acquiring and maintaining Chinese books, journals and databases in the Bodleian Libraries.

4. The administration of the Fund, and the application of its income, shall be the responsibility of Bodley's Librarian, subject to the oversight of the Curators of the University Libraries.

5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund.

7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

8. Regulations 1–10 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

9. Subject to Regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

(f) Establishment of the Rangoonwala Visiting Fellowships Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the gift from the ZVM Rangoonwala Foundation, for the purpose of the advancement of education for the benefit of the public, in particular by supporting visiting fellowships to be known as the Rangoonwala Visiting Fellowships.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'Rangoonwala Visiting Fellowships Fund

1. The University receives with gratitude initial gifts totalling £323,100 from the ZVM Rangoonwala Foundation to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Rangoonwala Visiting Fellowships Fund ("the Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express

understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the advancement of education for the benefit of the public, in particular by supporting visiting fellowships to be known as the Rangoonwala Visiting Fellowships ("the Fellowships").

4. The Fund will make provision for the holders of the Fellowships each year to undertake research and study within the Oxford School of Global and Area Studies at the University.

5. The holders of the Fellowships will be appointed by the University each year having regard for the conditions imposed by the original gift agreement.

6. The administration of the Fund, and the application of its income, shall be the responsibility of the Social Sciences Divisional Board.

7. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

8. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund.

9. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

10. Regulations 1–5 and [6–12] shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

11. Subject to Regulation 12, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

12. Any amendment to Regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.

The voting period will close at 4pm on 26 November.
