Resolution and proposed amendments on Statute XI

A legislative proposal was published in <u>Gazette No 5422</u>, <u>23 May 2024</u>, <u>p465</u> in relation to Statute XI: University Discipline, plus consequential amendments to other legislation. Notice of opposition and a proposed amendment were subsequently received.

The legislative proposal was withdrawn from the agenda of 11 June and the corresponding resolution was on the agenda of Congregation for 25 June (10th week of Trinity term 2024). A proposed amendment to the resolution was submitted by two members of Congregation. As per Congregation regulations, the Proctors were asked to consider an adjournment, to which they agreed. The resolution is therefore on the agenda of the first meeting of Congregation of the new academic year (15 October).

Subsequently, the original amendment was withdrawn and a new proposed amendment was received and published in <u>Gazette No 5429, 18 July 2024, p8</u>. The resolution and the second proposed amendment are set out below.

As the implementation of the Higher Education (Freedom of Speech) Act 2023 has been paused, approval from the movers of the resolution and of the amendment has been given to remove reference to this and the associated guidance. Approval has also been given to remove the reference to 0th week from the resolution, since the meeting of Congregation will take place in 1st week. The amendments are shown in red below.

Congregation Regulations 2 of 2002 state that unless opposition to the amendment is received eight days before the meeting, 'the amended resolution shall, at the conclusion of any proceedings on the amendment and the resolution, be declared by the Chair to be carried without question put...' (3.16 (3) (a)). Any member who intends to vote against the amendment must give give notice in writing to the Registrar of their intention no later than **Monday, 7 October**.

Text of Resolution:

'1) That Statute XI, as subject to any amendments, be shown to be consistent with (i) the current legal duties upon the University, including but not limited to the Human Rights Act 1998, the Education (no. 2) Act 1986, the Equality Act 2010, and the Higher Education (Freedom of Speech) Act 2023, as well as recent developments in associated domestic and international case law and (ii) the protections and rights that this University has extended to its faculty, staff, and students in previous resolutions of Congregation, including but not limited to academic freedom as defined in Statute XII reference to the UNESCO Recommendation.

2) That a Steering Group is formed and comprised of relevant University officials, representatives of the Conference of Colleges, and no less than five elected members of Congregation no later than Oth week of Michaelmas term 2024. The purpose of the Steering Group is to review Statute XI, and consider any amendments, alongside relevant policies and guidance, with an eye to ensuring that the provisions reflect human rights law, and the existing protections and freedoms extended to its members by this University.'

Proposed amendment:

'That a university working group shall be convened to recommend revisions to the proposal for amendments to Statute XI previously submitted to Congregation for a meeting on 11 June 2024, so that the proposal can be implemented subject to those revisions. This work should begin in MT2024. The Working Group shall include relevant university officials, a student appointed by the Student Union, and five members of Congregation (one appointed by Conference of Colleges and four appointed by each of the four divisional boards from within their own division) who will bring relevant experience and expertise to the Working Group (for example, experience of student welfare, disciplinary processes, expertise in human rights law and in legislation relating to freedom of expression and academic freedom). Appointments shall be made at the earliest opportunity in MT2024 following a call for expressions of interest. The Working Group shall consult widely with members of academic staff and professional services, as well as students, to help

inform their recommendations. It shall then submit an amended legislative proposal for changes to Statute XI to Education Committee, General Purposes Committee and Council. Noting that this work may usefully be combined with that needed to implement the OfS-Regulatory Guidance on Freedom of Speech, but that it is not yet known when that guidance will be available, the The remit of the Working Group shall include consideration of the legal context within which Statute XI operates including: (i) all relevant law, including but not limited to the Human Rights Act 1998, the Education (no. 2) Act 1986, the Equality Act 2010, and the Higher Education (Freedom of Speech) Act 2023, as well as associated domestic and international case law and (ii) the protections and rights that this university has extended to its faculty, staff, and/ or students in previous resolutions of Congregation, including but not limited to academic freedom as defined in the Statute XII reference to the UNESCO Recommendation.'

Arrangements for the meeting

The meeting will be held at 2pm on 15 October in the Sheldonian Theatre. The doors will be opened at 1.30pm. Attendance at the meeting is open to members of Congregation and a nominated member of Oxford SU. Admittance to the theatre will be on production of a member's University Card stating 'Congregation', and will be on a first-come first-served basis. Since it is possible that some members will not have been issued with a new card, identity may also be checked against the Register of Congregation at the entrance. Please make sure that the details on cards are legible. New cards may be obtained from the University Card Office. Information on eligibility requirements for membership of Congregation and how to apply is published at https://governance.admin.ox.ac.uk/congregation.

A level access entrance to the theatre and flat floor seating is available. There is a fixed induction loop. Order of business

The Chair will open the meeting at 2pm and set out the procedure and order of business.

If no opposition to the amendment has been received by the published deadline, the Registrar will read out both the original and the amended resolutions. The Chair will then declare the amendment carried.

If opposition to the amendment has been received:

- 1. The resolution will be moved and seconded;
- 2. The amendment to the resolution will be moved and seconded:
- 3. Voting on the amendment will take place by paper ballot and the result will be announced:
- 4. If the amendment has been carried, there will not be a vote on the finally amended resolution, as the amendment will be considered final;
- 5. If the amendment has not been carried, there will be a vote on the original resolution.

Voting

If opposition to the amendment is received by the published deadline and voting takes place, the Vice-Chancellor and the Proctors have determined that voting during the meeting will take place by paper ballot. Voting papers will be handed out on arrival. Members must vote in person and may not ask another member to submit their completed paper on their behalf. When a vote is called, members of Congregation will be required to identify themselves on their voting slips by name and signature and by college/department or faculty and to deposit their own voting slips in ballot boxes at the doors of the theatre. Slips will be sorted and counted by the Proctors, and will subsequently be kept confidentially by the Proctors for six days, after which they will be destroyed.

Transcript

Election of the next Chancellor

The Chancellor is the titular head of the University. In February 2024, Chris Patten, Lord Patten of Barnes, announced that he would retire as Chancellor at the end of the 2023–24 academic year. The incoming Chancellor will be in post for a term of 10 years in accordance with the Statute IX amendments enacted earlier this year.

The election of the Chancellor will be held during Week 3 of Michaelmas term (week commencing 28 October). The election will be conducted in accordance with the provisions of Council Regulations 8 of 2002 (*Gazette* No 5421, pp440–1); these regulations are available on the University website at: https://governance.admin.ox.ac.uk/legislation/council-regulations-8-of-2002.

VOTER REGISTRATION

Members of Congregation are automatically registered to vote in the election of the Chancellor. Other members of Convocation were required to registered to vote online by 18 August. Voter registration is now closed.

VOTING ARRANGEMENTS

The election will be held online only. As outlined from 8 July on the Chancellor's election webpage (www.ox.ac. uk/about/organisation/university-officers/chancellor/ chancellor-election), the Alternative Vote system will be used, whereby voters can rank as many of the candidates as they choose. If the number of candidates in this election is fewer than 10, there will only be one round of voting, and lower-ranking candidates will be eliminated until one candidate achieves 50% of the vote. If there are 10 or more candidates, a second round of voting will be triggered. In this scenario, votes would be counted using the standard Alternative Vote method, but only up to the point where 5 candidates remain. These 5 candidates will go forward to a second round, to take place during Week 6 of Michaelmas term. The new Chancellor will be announced during Week 7. Registered voters will receive emails with a link to cast their vote for both of these rounds if two are required.

THE CHANCELLORSHIP

Statutory provision

Statute IX, sections 2-5, provides as follows.

'2. The Chancellor shall be elected by Convocation and shall hold office for a fixed period decided by Council or until their resignation.

- 3. There shall be a Chancellor's Court of Benefactors to membership of which the Chancellor may from time to time admit major benefactors of the University.
- 4. The Chancellor shall have such other functions and powers as are assigned to them by the statutes and regulations or by the law of the land.
- 5. In the event of the incapacity or absence abroad of the Chancellor, or during a vacancy in the Chancellorship, or on delegation from the Chancellor, the Vice-Chancellor may exercise any of the functions and powers of the Chancellor, except where the statutes provide otherwise.'

STATEMENT ON THE CHARACTERISTICS OF A CHANCELLOR

For the guidance of candidates and electors

The Chancellor is the ceremonial head of the University of Oxford. While this key role has no executive responsibilities, it is more than symbolic; the Chancellor provides supportive and useful advice and guidance to the University, particularly to the Vice-Chancellor. The Chancellor presides at events such as Encaenia and at the Chancellor's Court of Benefactors and is sometimes expected to take a leading role at other official events. The Chancellor is the Visitor (an external figure of authority on whom the college can call for advice and for arbitration if insoluble dispute arises among its governing body) of five colleges and also chairs the Committee for the Nomination of the Vice-Chancellor. In addition to these formal duties, the Chancellor undertakes advocacy, advisory and fundraising work, acting as an ambassador for the University at a range of local, national and international events. The Chancellor must be readily accessible and available throughout the


